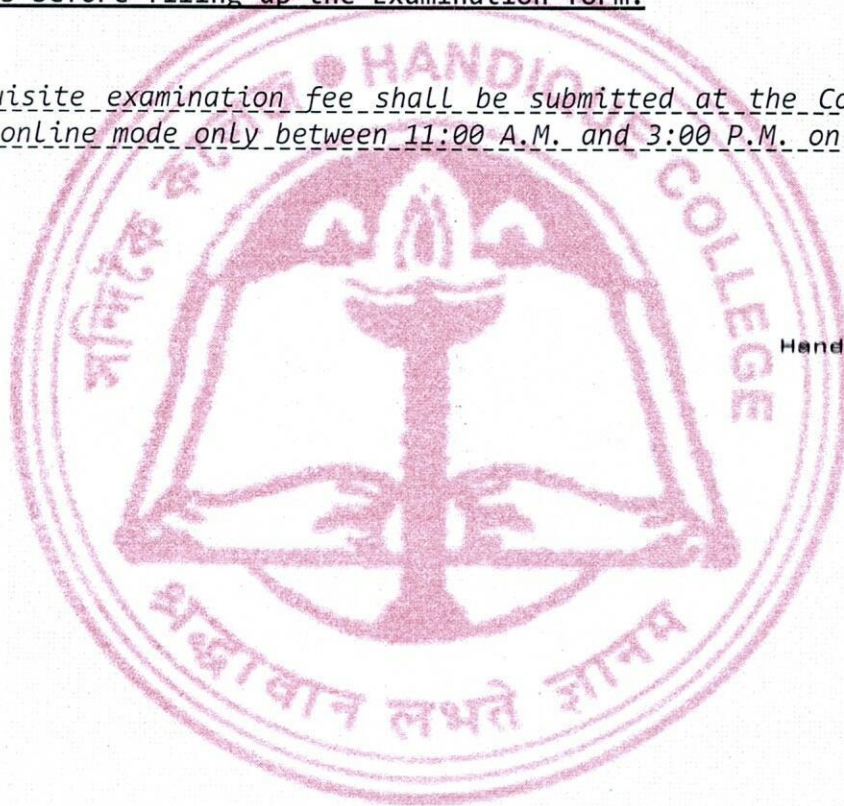

No. ASSEB/CoE/Exam/25/Notification/478: It is for information of all concerned that the ASSEB, Division-II is planning to hold the Higher Secondary Final Examination-2026 in February/March, 2026. In this connection, the process of online form fill up will be started from the **22nd of October, 2025** and will be closed on the **25th of November, 2025**. Accordingly, all the Heads of the Institutions under the jurisdiction of the ASSEB, Division-II are requested to notify their students regarding the process of online form fill up during the said period **SO THAT NO ELIGIBLE STUDENT IS LEFT OUT OF THE FORM FILL UP PROCESS**. The respective portal for online form fill up will be opened in due course of time and the same will be intimated to the institutions. The fee structure for the ensuing H. S. Final Examination-2026 is annexed herewith for your references.

Further, it is also to be noted that the ASSEB, Division-II will not allow any provisional / offline form fill up in the ensuing H. S. Final Examination-2026. If any student is left out to fill up form within the stipulated time, then he/she will not be able to appear in the forthcoming H. S. Final Examination 2026.

Furthermore, the Registration Number of a student shall be kept valid for a maximum period of 5 years from the date of registration of the student in the ASSEB, Division-II. After expiry of stipulated time frame of 5 years of the Registration, the concerned student will be allowed to fill up the form after taking special permission for re-registration from the ASSEB, Division-II before start of the form fill up process.

In pursuance of the Govt. notification issued vide No. E-238074/471 dated 07.11.2022, the Centre fees/Examination Fees etc. are exempted in respect of the examinees of Govt./ Provincialized /Recognized Venture Schools /Colleges who are going to appear in the H. S. Final Examination-2026 and whose parental annual income taken together from all sources is Rs. 2.00 lakhs or below.

In addition to the above, all the Heads of the Institutions under jurisdiction of ASSEB, Division-II are informed that only the students of a **Permitted Recognized Streams will be considered as REGULAR students** (appearing for the first time in the H. S. Final Examination-2026). Other all the students registered for the session **2024-25** will be considered as **INSTITUTIONAL PRIVATE (I.P.)** and they have to bear the **I.P. fees**. *That means If an institute was Permitted under ASSEB, Division-II and did not get the Recognition Status in the permitted stream(s) from ASSEB, Division-II*, their students whose Registration Session are 2024-25 and those who are appearing for the first time in the forthcoming H. S. Final Examination-2026 will be treated as **INSTITUTIONAL PRIVATE (I.P.)** candidates and accordingly, such candidates shall have to bear I.P. fees. Moreover, if an institute is entitled with Recognition status in the permitted streams but did not have the subject permission for a particular subject(s), in such cases, those students will be treated as **INSTITUTIONAL PRIVATE (I.P.)**.

IN NO CASE, SUBJECT CHANGE WILL BE ALLOWED DURING OR AFTER COMPLETION OF FORM FILL UP PROCESS.

The ASSEB, Division-II solicits help and cooperation in this regard from all concerned to enable it to complete the process of online form fill up smoothly and timely.

No. ASSEB/CoE/Exam/25/Notification/ 478(A) It is hereby notified for information of all intending eligible candidates of following categories that they will be able to fill up forms for H. S. Final Examination, 2026 subject to fulfilment of conditions described below -

- a) *Under Betterment Chance / Re-appearance Scheme.*
- b) *In Certain Subject*
- c) *Under Compartmental Category*
- d) *Under Repeat Category*

a) **UNDER BETTERMENT CHANCE / RE-APPEARANCE SCHEME**

A student who passed the H. S. Final Examination, 2025 for the first time and is intending to appear in the ensuing HS Final Examination, 2026 under the Betterment Chance / Re-appearance Scheme should apply through online form fill-up portal. They are not required to avail prior permission from the ASSEB, Division-II.

Such students desirous of appearing in the Betterment of Result Scheme will be allowed for maximum 4 (four) subjects only of his/her combination of subjects offered in the H. S. Final Examination-2025 (Arts/Science/Commerce/Vocational streams). Students appearing under Betterment of Result Chance must appear in Practical Examination also if subject(s) contain(s) practical paper(s).

If a candidate secures higher mark in subject/subjects under the Betterment of Result Chance in the H. S. Final Examination, 2026 then the mark(s) of the subject(s) of the previous H. S. Final Examination, 2025 would be replaced in the new mark-sheets by mark obtained in its H. S. Final Examination, 2026 and the other marks will be retained as it was. *Only one mark-sheet will be issued to a candidate under this Betterment of Result scheme on surrendering the previous mark-sheet.*

Under Re-Appearence Scheme, the candidate who passed the H. S. Final Examination 2025 and wish to improve upon his/her performance to attain the eligibility criteria for admission in Engineering, Medical etc. through competitive examination, he/she will be allowed to reappear in all subjects, with which he/she appeared in the last examination and the better result will be taken into account. Under no circumstances Better Mark obtained in single or any subject will be added with the previous result. In respect of all competitive Examinations, the candidate will decide before applying whether he/she will appear under Betterment Chance or Re-appearance Scheme in the Examination. Students appearing under Re-appearance Scheme must have to appear in Practical Examinations also if subject(s) having practical paper(s).

In any circumstances, change of scheme will not be allowed after filling up the on-line form fill up process. That means, if a candidate chooses Re-appearance Scheme during form fill-up process and later on appear in the H. S. Final Examination-2026 with one or two or three or four subjects and then claim to Change to Betterment Chance after declaration of results, that will not be entertained.

b) IN CERTAIN SUBJECT

1. Candidates who passed the H. S. First Year Examination, 2025 in certain subject with due permission from the ASSEB, Division-II are required to obtain similar permission for appearing in the H. S. Final Examination, 2026 in the same subject.
2. A candidate of the H. S. Final Examination of previous years, who could not pass/could not appear in the fourth elective subject and if he/she is eligible for appearing in that subject as evinced from the Admit card and Marks-sheet, may appear in the H. S. Final Examination, 2026 in that subject under CERTAN SUBJECT scheme. He/ she will have to apply through the online Form Fill up portal.

c) UNDER COMPARTMENTAL CATEGORY

A candidate who could not come out successfully in the last H. S. Final Examination-2025 due to not achieving pass mark in a particular subject, such candidate may appear in the forthcoming H. S. Final Examination-2026 either under COMPARTMENTAL category for the said subject (for which he/she could not pass the last examination) or as **REPEAT Category** with all subject combinations with which he/she appeared in the H. S. Final Examination-2025. Such candidates shall have to apply through online form fill-up portal.

In any circumstances, change of scheme will not be allowed after filling up the on-line form. That means, if a candidate chooses all subjects during form-fill up process and later on appear in the H. S. Final Examination-2026 with that particular subject for which he/she could not pass the last H. S. Final Examination-2025 and then claim to Change to COMPARTMENTAL Category after declaration of results, it will not be entertained.

d) UNDER REPEAT CATEGORY

A student whose result was REPEAT in the earlier H. S. Final Examinations (within the allowed Registration Session) and whose result was either **Compartmental** in the H. S. Final Examination, 2025 or **Compartmental** in earlier H. S. Final Examinations, may appear in the ensuing H. S. Final Examination, 2026 as **Non Institutional Private (N.I.P.) Candidate** and such candidates shall have to apply only through the online form fill-up portal.
